67th Legislative Session Adjourns after Midnight



The 67th Legislative Assembly of the State of North Dakota adjourned sine die at about 12:15 a.m. on Friday, April 30.

Once again, the Office of Management and Budget's appropriation bill (HB 1015), which is often used as a catch-all for last minute amendments, was the last bill out.

Legislators worked into the wee hours of the morning in order to save four legislative days, as adjourning and coming back would have cost them another day. If they choose to do so, the legislature will be able to call themselves back into session to address additional federal funding with the remaining days. They will also reconvene in November or December, likely at the call of the Governor, to redistrict – something that happens every ten years following the census. Finally, Legislative Management will meet on May 19 to select interim studies – a number of which could be very significant to NDSBA members.

While there were a few losses, we believe K-12 education fared well this session. Board members are encouraged to review the full legislative wrap-up emailed to them on April 30. In addition, NDSBA will be focusing its June 16 Lunch and Learn webinar on the 2021 Legislative Session. Board members, business managers, and administrators are welcome to register

HB 1388 is likely the most significant piece of education-related legislation passed this session. It was also one of the last education bills to be finished. It establishes changes to the policy for implementing the K-12 funding formula and was the “catch-all” bill for issues germane to education. After many days of disagreement among the conference committee members assigned to the bill, Senate members persisted and were able to convince the House members to agree to a 1/1 per pupil payment increase (\$10,136/\$10,237).

In addition to the increase in the per pupil payment, HB 1388 does the following:

- Adjusts the small school district size weighting factors.
- Provides the ability of a school district to meet instructional time requirements through a virtual instruction program that meets certain criteria. It also includes provisions to account for virtual instruction in the ADM calculation.
- Adds a reading competency component to the teacher licensure requirements and additional requirements to reading curriculum.
- Adjusts the timing for the phase-out

of moving transition maximum school districts onto the K-12 funding formula.

- Provides for a legislative management study of K-12 funding, including transition minimum reduction impacts on reorganized and consolidated school districts.

Many of the sticking points regarding funding issues centered around the federal funding received by school districts over the past year. Some legislators would have preferred to supplant more state dollars with these funds. The wise, thoughtful, spending of these dollars by school districts will be very important to the success of our future funding negotiations at the legislature. School board presidents or their designee are strongly encouraged to join their superintendents and business managers in attending the ESSER Training hosted by NDCEL, NDSBA, and NDSOS on June 3 in Bismarck. Now that all of the bills have been signed, NDSBA staff has begun working on guidance regarding policy changes and new requirements. We will distribute that information as we finalize

Legal Spotlight

HB 1349: New Changes to Open Meetings Requirements and Hiring Practices

Over the past several months while schools have been dealing with the challenges presented by the pandemic, school boards have been able, pursuant to Executive Order 2020-16, to fulfill the public access to meetings requirement through electronic means without the need to provide a physical location. By its terms, this order remained in effect for the duration of the declared state of emergency. However, with the Governor's recent declaration that the emergency period is over as of April 30, 2021, Executive Order 2020-16 has expired. As such, school boards must now provide a physical location for public access to their meetings. Boards may provide an option for public access to meetings via virtual means, but it must be in addition to access at the physical location of the meeting at least until August 1, 2021. On that date, HB 1349, which passed during the recent legislative session, will become law.

HB 1349 made some important changes to the open meetings

requirements set forth in NDCC chapter 44-04, namely the ability of a public entity to hold meetings by electronic means and to provide public access by electronic means. To hold meetings by electronic means under the new law, the electronic capacity must accommodate the number of persons reasonably expected to attend the meeting remotely. In addition, the information necessary to join or view the meeting electronically must be included in the notice issued pursuant to NDCC 44-04-20. The notice required in that section must contain the date, time, and location of the meeting. The bill confirms that for meetings to be held by electronic means, the location of the meeting is the electronic address and any other information necessary to allow the public to join or view the electronic meeting.

School boards may still hold meetings in person at a physical location as they have always done. HB 1349 provides more flexibility for school boards and other public entities to take advantage of available technology to conduct public business. These changes should make it easier for school boards to continue to conduct public business during inclement weather events and unforeseen public health emergencies, as well as those common situations where it is difficult to schedule a meeting at a time when all board members are available.

HB 1349 also made some slight changes to section 44-04-18.27, which relates to hiring by public entities. Currently, section 44-04-18.27 requires a public entity that is hiring for a vacant position and receives applications from three or more qualified candidates to designate three or more qualified applications as finalists for further

consideration before the public entity may issue an offer of employment to fill the position. This section applies to public school districts and to any position being filling by a district (from part-time cook to superintendent, for example). Section 44-04-18.27 also provides that the applications and any records related to the applications which contain information that could reasonably be used to identify an applicant are confidential and may not be disclosed to the public except as provided by law. Once finalists are designated, the application and records related to finalists become open to the public. If the public entity receives applications from less than three qualified candidates, the applications and records are open to the public from the outset.

Under HB 1349, the applications and records relating to the applications (including the identities of the applicants) are exempt, as opposed to confidential. This means the public entity may exercise discretion as to whether to keep such information from the public or to make it open to the public. Once finalists are designated, the applications and records relating to finalists are still open to the public. The exempt status relates to all applications and related records during the time period prior to the designation of finalists and then to the applications and records relating to non-finalists once finalists are designated. The bill also clarifies that public entities may adopt policies regarding the release of exempt records under section 44-04-18.27.

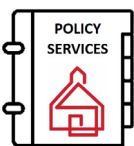

Two examples are House Bills 1232 (virtual instruction) and 1478 (alternative education opportunities). NDSBA cannot issue policy templates or updates until this process is complete, but please do not hesitate to contact us with any questions in the meantime.
